

## CFR Title 21, Part 11 Attestation

Part 11 of Title 21 of the Code of Federal Regulations establishes the criteria under which the U.S.: Food and Drug Administration (FDA) considers electronic records, electronic signatures and handwritten signatures executed to electronic records to be trustworthy, reliable and generally equivalent to paper records and handwritten signatures executed on paper. The 2015 Edition Health IT Certification Criteria (2015 Edition) builds on past rulemakings. On October 16, 2015, the 2015 Edition Health Information Technology (Health IT) Certification Criteria, 2015 Edition Base Electronic Health Record (EHR) Definition, and ONC Health IT Certification Modifications was published. Froedtert Hospital and the Medical College of Wisconsin use the Epic EHR as the legal medical record to collect standard clinical data for patients participating in clinical studies.
